2017 Montgomery County JV Volleyball Tournament Saturday 8-26-17 (9:00am)

- Game Time:** Games will begin at 9a.m. sharp with a 3-3-1 warm-up. After each team has played one match the warm-ups will be in the shared 3 -1 format.
- Tournament type:** A Six Team Tournament with championship bracket following pool play. Top team from each pool will have a bye, next 2 will move to playoff bracket.
- Tournament Format:** **In pool play, matches are best of 2 games starting at 4 points, win by 2. No Cap!**
Games won will determine position. In the case of a tie, the breaker will be determined by this order:
1. Head to head point differential
2. Overall point differential
3. One set play-off to 15.
Bracket play is best two out of three games to 25. No Cap!

General Tournament Information

- Please note we are going to use both the High School and the new Middle School gym. The new Middle School gym is located right beside the HS. Since we are using both gyms which should speed up the process we are going to start at 9:00am instead of 8:00am. Gyms will be opened at 8:15am for warmups.
- Practice Balls will be provided. PLEASE DO NOT BRING YOUR OWN!
- A concessions stand will be provided for all fans and players **IN THE HS GYM ONLY!**
- There will be NO hospitality room but each school (Coaches and Drivers) will have a 20 dollar credit at the concession stand all you need to do is tell them your name, school, and position.
